Engaging with Regional Awards

One of the highlights of the year has been the opportunity to attend the regional awards across the country. These events are a testament to the innovative and resilient spirit of New Zealand farmers and growers, who are constantly seeking to improve their environmental stewardship while maintaining the productivity and profitability of their land. Meeting these dedicated individuals and hearing their stories has reinforced the importance of the Trust's mission and the impact we can have on the future of New Zealand's primary industry.

This year also marked a significant milestone with the celebration of 21 years in Canterbury and 20 years in Otago, highlighting the enduring commitment of these regions to the BFEA programme.

The number of entries remained strong through the regions, with a total of 65 sheep, beef, dairy, arable and growing operations represented across 10 regions.

The Regional Committee Charter, including a Committee Member Code of Conduct, continues to guide the regions in the governance of the Ballance Farm Environment Awards (BFEA). The Chairs have seen one change for the year (Northland), and have benefited from coming together on a quarterly basis, which has created a supportive network for collaboration and new initiatives. The regional coordinators and judging coordinators have also seen changes. The vast volunteer base and our contracted coordinators are the heart of our regions, and we are very thankful for the passion and hours of dedication they bring to the programme.

The Role of our Trustees

A special thank you to Joanne van Polanen, who stepped down as Chair of the Trust in October. Joanne had a long involvement with the Trust, starting as the Canterbury BFEA judging coordinator before joining the Trust Board in 2010. She brought her passion for the primary industry to both of these roles, and we are incredibly grateful for her dedication over the years

We were delighted to welcome Rex Anderson, Rick Mannering, Karen Williams and Fiona Young to the board in August 2023. Our trustees bring a wealth of experience and a deep understanding of the challenges and opportunities facing the agricultural sector. Their commitment to the Trust's mission is evident in their active participation in guiding our strategic direction, overseeing our programmes, and ensuring that we remain true to our core values of sustainability and environmental stewardship.

The trustees work behind the scenes providing valuable insights, fostering key relationships, and supporting the team in every aspect of their work. The trustees' leadership and vision are essential in navigating the complexities of our mission and ensuring that we continue to make a positive impact on the New Zealand farming and growing community.

A review of the Trust Deed was a significant focus over the past 12 months. It also provided us with an opportunity to ensure our mission and strategic focus were accurately reflected in our guiding document.

Promoting Sustainable Farming & Growing

This year, with the backing of MPI's On Farm Support team, we piloted a new programme, (Farming for the Future), in four BFEA regions — Canterbury, East Coast, Auckland and Greater Wellington. Farming for the Future has a dual purpose: sharing sustainability stories with a wider audience and developing leadership and ambassadorial skills for our BFEA Regional Supreme Winners, who form an integral part of our alumni network.

We have expanded our media relationships to increase the reach of farmer and grower stories and boost brand awareness. We have increased our social media presence, with active BFEA Facebook pages in all 11 regions and Trust profiles on Facebook and Instagram. These platforms allows for greater reach with regional content. As these regional pages continue to grow, they will become valuable mechanisms for sharing stories and building community around the BFEA programme.

National Sustainability Showcase Success

The year culminated in a very successful National Showcase, where we celebrated the achievements of the best and brightest in New Zealand farming and growing. The event was a remarkable demonstration of what is possible when passion, innovation, and a commitment to the environment come together.

Treasurer's Report

It is my pleasure to present the financial results of the New Zealand Farm Environment Trust for the financial year ending 30 June 2024.

The Trust's accounts have received an unqualified independent audit certificate.

For the 2023/24 financial year, the New Zealand Farm Environment Trust recorded a surplus of \$46,000. This outcome reflects the combined efforts of both the national team and the regions, with regions generating additional income and managing costs effectively in a challenging financial environment.

Financial Performance Overview

Total revenue:

• \$1,068,000 (2023/24), compared to \$1,249,000 (2022/23)

Total expenses:

• \$1,023,000 (2023/24), down from \$1,140,000 (2022/23)

While the Trust achieved a surplus this year, we are forecasting a deficit for the 2024/25 financial year, which will be funded from our reserves.

Notes

1. Analysis of Revenue

Revenue from providing goods and services includes: national sponsor income, national partner income, regional partner income, regional sponsor income and income from ticket sales (regional function/national showcase).

2. Analysis of Expenses

Costs related to providing goods and services include: national personnel and related expenses, regional coordination expenses (including contractor fees), regional award expenses, communications and public relations expenses, prizes for regions, national award expenses, national coordination expenses, national showcase expenses, meeting expenses and project expenses.

Other expenses include: accounts and audit, administration, governance expenses, professional services, insurance and depreciation.

3. Prior Period Adjustment

Sponsorship for the 2023 Leadership Summit was not accrued as a receivable for the 2023 financial year. This has been included as a prior period adjustment for the 2023 comparatives. The impact of this adjustment is to increase the 2023 project income, surplus, accounts receivable and accumulated funds by \$20,000.
